# COUNCIL SESSION 96-10 November 5, 1996

# **Summary Record**

Designated Alternate Representatives met via teleconference on November 5, 1996, for a special session. The agenda can be found as Annex "A".

# Item 1 - Identification of participants and approval of agenda

Mr. William Nitze chaired the meeting. Mr. Anthony Clarke and Mr. José Luis Samaniego represented Canada and Mexico, respectively. Mr. Jonathan Plaut, Chair of JPAC, and Mr. Victor Lichtinger, Executive Director of the Secretariat, also participated in the teleconference. Mr. Marc Paquin acted as Secretary. Other officials were in attendance.

The Chair requested that items 7 and 8 be moved to the top of the agenda. The agenda was approved as modified further to the Chair's request.

# **Item 7 - 1996 Contribution - Schedule of Payments**

Canada reported that it will pay its remaining balance (\$US 1,535,000) by December 1996. Mexico has just paid approximately \$US 2,000,000, leaving a small unpaid balance. The US has already paid its 1996 contribution in full. The Secretariat informed the Parties that its current cash resources will cover operations until February 1, 1997.

The Executive Director informed the Parties that the Third Quarter Financial Report will be sent to them very shortly and that a small surplus is expected at the end of 1996. The Executive Director also mentioned that the Secretariat is awaiting sales tax reimbursements from the Government of Canada and Quebec.

# **Item 8 - 1997 Contribution - Schedule of Payments**

Approval of the draft resolution was postponed until Mexico finalizes its schedule of payments for 1997. Mexico will develop its schedule of payments which will then be incorporated into the draft resolution for adoption by the Parties. Canada and the US agreed to make quarterly contributions to ensure sufficient cash flow to the Secretariat.

# Item 2 - Remarks by Chair of JPAC

The JPAC Chair reported on the success of the public consultations held in 1996, including the public portion of the Council Session in Toronto. A report prepared following the public meetings has been distributed to all participants, the Parties and the Secretariat. Concerning the next JPAC meeting, which is to be held on November 7-8, 1996, the JPAC Chair presented the agenda and reported that the meeting will be focused around the discussion paper "Future Directions - JPAC Strategic Planning Proposal". Discussions will consider the proposed Annual Program and Budget for 1997, the NAFEC Administration and Funding Guidelines, the Guidelines on Enforcement Matters under NAAEC Articles 14 and 15, the approval of JPAC Public Consultation Guidelines, the terms of office for JPAC Members and, information about the election of the new JPAC Chair.

The Parties initiated a discussion concerning the possibility of financial support for the JPAC Chair. This issue will be discussed by the JPAC Chair and the Executive Director on November 6, 1996.

The US asked the JPAC Chair to give some thought to voluntary initiatives that could be developed in cooperation with the business sector. In response, the JPAC Chair referred to the Cooperation in Environmental Enforcement project; the Environmental Management projects beyond compliance programs with the CEC or between industry groups; the Pollution Prevention Fund for Small-and-Medium Sized Enterprises and, the actions under ISO 14000.

## **Item 3 - Remarks by the Executive Director**

The Executive Director introduced Marc Paquin as the new Secretary to Council. He then commented on the proposed 1997 Program and Budget and reported that current projects are progressing well. He informed the Alternate Representatives that a meeting of experts is being organized to assist the Secretariat in defining the scope of the Article 13 Report. A concept paper is being prepared for discussion at the meeting. The Alternate Representatives will be sent a copy of it as well as other materials relevant to the meeting. The Executive Director invited the Alternate Representatives to send an official to the meeting.

With respect to the streamlining of the NAFEC Guidelines, the Executive Director reported that the Grant Committee met in Montreal to suggest revisions to the Guidelines. Their proposals were transmitted to JPAC for discussion at its November meeting. The Secretariat will transmit the JPAC recommendation on the Guidelines once finalized.

The Executive Director reported on the reception at the CEC for North American participants to the IUCN Conference in Montreal and the CEC staff's appreciation of a visit by Julia Carabias, the Mexican member of Council, to the CEC during the Conference. Mr. Lichtinger also reported that the Secretariat has offered the CEC facilities for a Rio+5 meeting of the councils on sustainable development from the North American Region. The Secretariat is preparing a publication that relates the regional perspective of CEC activities to the objectives of UNCED.

The Executive Director asked the Parties if they wished to consider the report as a formal statement of the Council, or draft a preface message from the three ministers.

The Executive Director reported that the Sound Management of Chemicals meeting held in Mexico City last week represented a significant milestone in this project. He also informed the Council that the Secretariat has received complaints because the documentation was made available to the public only four days before the meeting. The Executive Director stated that, unless the Council was opposed to the idea, he would extend the comment period to allow broader participation. The Executive Director will notify the working group and will make the necessary arrangements for this extension period.

A draft agenda has been completed for the "Dialogue on Environmental Law" meeting in December 1996 and is ready for comments. The Executive Director asked the Parties to suggest names of senior officials that could participate in the meeting.

The Executive Director asked Mr. Greg Block to report on the status of the Cozumel submission. Mr. J.L. Samaniego requested a status report on the development of the process and Mr. Block reported that the Mexican government has been very cooperative and that the Secretariat is taking special care in considering the format of the factual record. Mr. Block reported that information is being collected and that a draft factual record would not be ready before 1997. Mr. Block also reported that the Secretariat is very close to making a determination under Article 14(2) on the Old Man River submission.

## **Item 4 - Approval of Summary Records**

Parties approved the Summary Records for Sessions 96-08 and 96-09.

The draft Summary Record of the 1996 Council Regular Session was discussed and all proposed changes, except to items 9.5 and 12, were agreed upon by the Parties. The Secretariat will listen to the tapes of the Session to clarify items 9.5 and 12.

# **Item 5 - Next Regular Session of Council**

The US proposed June 18-20, 1997, as the dates for the next Annual Regular Session of Council. They also informed the Parties and the Secretariat that the planned venue for the meeting is currently Burlington, Vermont.

## Item 6 - Items Carried-over from Session 96-07

## **Item 6.1 Headquarters Agreement (Canada)**

The Executive Director introduced Manuel Pacheco, the Administrator of the Secretariat. The Secretariat is awaiting a letter of clarification from the Government of Canada with respect to two articles in the Agreement: one respecting taxes and the other respecting the retroactivity of tax refunds owed to the Secretariat. Once finalized, copies of the Agreement and of the accompanying letters will be sent to each Party in the three languages. The adoption of the draft resolution authorizing the Executive Director to sign the Headquarters Agreement has been postponed to the next Alternate Representatives Session.

The Secretariat reported that the US State Department has received supplemental information, and that the Secretariat is hopeful the Agreement will be completed before January 1997.

# Item 6.4 Privileges and Immunities: Action Plan

The US stated that the Headquarters Agreement will resolve most of the issues under this item. Canada reported that it will develop, in cooperation with the Secretariat, a process for passport annotations for Canadians and send briefing letters to airport customs (particularly Toronto and Montreal). It was agreed that because entry into Mexico has not been a problem to date for Secretariat employees no action is required in this respect by Mexico at this time.

# **Item 6.5 NAAEC - Language Accuracy**

Canada shared with Mexico and the US a proposed revised French version in March 1996. Mexico and the US are to finalize their review of that proposed revised French version. It is hoped that the revised French version will be adopted by resolution at the December session of Alternate Representatives in Montreal. It would then be the object of an exchange of diplomatic notes between the three countries.

Canada and US have completed their proposed changes to the Spanish and will forward them to Mexico. Mexico will hold discussions with the relevant Mexican authorities on how to proceed with the revision of the Spanish version.

# **Item 6.7 Model Rules for Dispute Settlements**

The US presented three preliminary questions concerning the Model Rules: 1) Should the ABA text serve as the discussion text? 2) When should the discussions begin? 3) Should the environment and labor rules be discussed together? The Parties agreed that January 20, 1997, be the tentative date for a first negotiating session.

# **Item 9 - 1997 Program and Budget**

The Secretariat was commended for consolidating its projects to a total of 17 from 26 the previous year. The Parties will review the proposed Program and Budget more thoroughly, and agreed to take the necessary steps to be in a position to approve most, if not all, of the 1997 Program and Budget more thoroughly at the next Alternate Representatives Session in December 1996. Mexico suggested two possibilities for the expansion of the Program, i.e. Hazardous Waste Management and National Programs for Management of Wild Flora. Canada found the 1997 Program and Budget to be a good reflection of the priorities identified at the 1995 and 1996 Council Regular Sessions. The Executive Director expressed satisfaction concerning the Parties' comments and explained that the Secretariat had attempted to reflect cost allocation as accurately as possible. He reported that complete information on current projects should be ready for the December Alternate Representatives Session.

## **Item 10 - Annual Report**

Parties discussed the potential format of the enforcement section of the Annual Report and agreed that it would not be presented as a separate annex. The need to develop a long-term strategic plan for the Annual Report and the importance of having an organized compilation of CEC and Working Group reports accessible to the public were also discussed. The JPAC Chair mentioned that JPAC will discuss ways to strengthen the Annual Report at its November 1996 meeting.

## **Item 11 - Trade and Environment**

Canada reported that it has distributed a proposed agenda to the Parties for a possible meeting of Environment and Trade Ministers concerning this item. A teleconference between Environment and Trade officials of the three countries will take place before the December Alternate Representatives meeting. The Parties will consider new areas where the Secretariat can contribute to the Trade and Environment issue.

The Parties agreed that continuity is critical for JPAC and they agreed to the "staggered approach" in principle. The issue will be discussed at the November 7-8, 1996, JPAC meeting. A JPAC recommendation will then be forwarded to the Parties for a decision.
