#### SESSION 97-08 OF COUNCIL 20 October 1997

#### SUMMARY RECORD

The Council, represented by the Alternate Representatives, met via teleconference on 20 October 1997. The agenda of the Session can be found as Annex "A." Mr. José Luis Samaniego (Mexico) chaired the meeting. Mr. Avrim Lazar and Mr. Bill Nitze represented Canada and the United States, respectively. Mr. Victor Lichtinger, Executive Director of the Secretariat, participated in the session, together with other officials.

#### Item 4.2 Chair for the special session of the Council

At Mexico's request, Canada indicated it would consult with Minister Stewart to see whether she would be willing to Chair the special session of the Council.
