JPAC Public Forum on Advancing Environmental Justice in North America

Societies and governments worldwide are increasingly struggling with the devastating impacts caused by the current triple planetary crisis, which have unfortunately exacerbated environmental injustices, disproportionately affecting the most at-risk, impoverished, marginalized, and excluded individuals and communities, jeopardizing the protection of human and collective rights. The escalating, unequal burden of environmental deterioration calls for urgent action in North America and beyond, not only to address the impacts that climate change, pollution and biodiversity loss have had on their populations, but also to build a fair, just, equitable, and sustainable future for everyone.

As part of its 30th anniversary celebration, the Commission for Environmental Cooperation will reflect upon its decades of work to broaden its approach to environmental protection, by embracing an Environmental Justice (EJ) perspective to address this challenge. This year, the JPAC Public Forum will offer a platform to analyze and discuss the different dimensions of EJ and the way they are addressed in Canada, Mexico and the United States.

The Forum will draw from JPAC's network of partners, highlighting stories and examples of at-risk and historically marginalized communities where, through EJ action, key actors, including local community-led organizations, individuals, NGOs and Indigenous community representatives, have worked to raise awareness of environmental justice issues and address them.

Over the next decade, North America will confront a multitude of pressing environmental and social challenges, ranging from climate change and biodiversity loss to disparities in resource access and social inequities. These critical issues demand our urgent attention and concerted efforts to tackle environmental degradation, while simultaneously addressing systemic inequalities and injustices entrenched within our societies.

Through the lens of environmental justice, this keynote will delve into the interconnected complexities that shape our journey to 2030. It will examine how environmental degradation disproportionately impacts at-risk, impoverished, marginalized, and excluded populations, threatening their health, livelihoods, and human and collective rights. Furthermore, it will explore how environmental justice is understood and addressed in North America, shedding light on the most relevant environmental justice topics and challenges in Canada, Mexico, and the US today.

Historically, the environmental burdens resulting from the use and misuse of the land and its resources have been distributed unequally, with the poor, marginalized and minority communities bearing much of the load. Environmental law and policy need to prevent this from occurring by addressing the gap with clear legislative requirements, accountability mechanisms, and public policies.

This panel session will present various examples from Canada, Mexico and the United States of legal and policy mechanisms and instruments used to access and implement environmental justice.

Environmental justice acknowledges the overlapping nature of injustices affecting marginalized communities and the Earth, and identifies how they are interconnected. As a grassroots movement, EJ is redefining the sustainability agenda: bringing injustices done to the most marginalized communities, and to the Earth, to the forefront and integrating a strong social justice dimension.

Additionally, it will provide a platform to discuss current EJ challenges in Canada, Mexico, and the United States and to share reflections on the future trajectory of EJ in North America.
