Preliminary Program of Public Events

For over twenty years, the North American Commission for Environmental Cooperation (CEC) and the Joint Public Advisory Committee to the CEC (JPAC) have promoted public health benefits and environmental sustainability under the North American Free Trade Agreement (NAFTA), through public dialogue, focused research, and regional cooperation.

The JPAC workshop in Charlottetown will engage the public in a discussion of how best to advance this core mission by examining the innovative approaches of local entrepreneurs and communities to trade-related water system challenges in Canada, Mexico, and the United States The session will highlight innovative local solutions that address regional issues, or that might be replicated elsewhere in the region to promote sustainable job growth and economic prosperity.

Drawing on the importance of coasts and surrounding waters to Prince Edward Island, the location of this year's Council and JPAC sessions, the session will focus on water-related challenges and opportunities of populations living along coasts, estuaries, and lakes (littoral communities) as well as rivers (riparian communities). It will feature panels and roundtable discussion on: (1) Sustainable and innovative water-related businesses: Benefiting local economies while protecting the environment; (2) Increasing resilience through cooperation: Replicating innovative local solutions to environmental security challenges; and (3) Sustainable economic growth on the water's edge: Protecting water-based jobs and communities through water-based conservation.

The workshop will draw on examples from all three NAFTA countries, highlighting the economies and cultures of large and small communities that are directly tied to the water, and the resilience of those communities when challenged by environmental issues related to water and extreme weather events.
