

SUBMISSIONS ON ENFORCEMENT MATTERS—Overview of the Implementation of Articles 14 and 15 of NAAEC

[Article 14](#) of the North American Agreement on Environmental Cooperation (NAAEC) gives the Secretariat authority to consider submissions from any non-governmental organization or person asserting that a Party to NAAEC is failing to effectively enforce its environmental law (a “submission on enforcement matters,” or “SEM”). If the submission meets certain criteria and if the Council instructs the Secretariat to do so, the Secretariat prepares a factual record on the matters raised in the submission ([NAAEC Article 15](#)). The Secretariat neutrally and independently reviews submissions, and can be likened to a fact-finding body that does not determine whether or not a Party has effectively enforced its environmental law. When the Secretariat produces a factual record, it is up to the public to draw conclusions and determine what next steps, if any, should be taken.

This citizen submission process was one of the prized achievements of the environmental community following the debate over NAFTA. It is one of the most valued, and at times controversial, elements of the NAFTA/NAAEC environment package. The controversy stems chiefly from a perception that the Parties attempt to interfere with the Secretariat’s neutral and independent administration of the process, that the process takes too long, and that factual records rarely respond to submitters’ concerns. However, in 2010, the Parties undertook efforts to improve the timeliness of the process and take other steps in an effort to respond to these concerns.

Since 1994, the Secretariat has received a total of 83 submissions (of which 12 are currently active) and has published 17 factual records. Thirty-one of the total submissions refer to Canada, 41 to Mexico and 10 to the US (including one that refers to both the US and Canada). Over these first 20 years of the existence of NAAEC, many issues concerning the implementation and interpretation of Articles 14 and 15 have arisen. The following recaps the main events related to the implementation of Articles 14 and 15. The [SEM Registry](#) provides overviews of the submissions filed to date, as well as links to the submissions themselves, all Secretariat determinations, Party responses, and the factual records published to date.
