COUNCIL SESSION 96-07 June 28 1996

Summary Record

Designated Alternate Representatives met via teleconference on June 28, 1996 for a special session. The agenda can be found as Annex "A". Mr. Anthony Clarke chaired the meeting. Mr. William Nitze and Mr. José Luis Samaniego represented the United States and Mexico respectively. Mr. Jonathan Plaut, Chair of JPAC and Mr. Victor Lichtinger, Executive Director of the Secretariat also participated in the teleconference. Other officials were in attendance.

APPROVAL OF AGENDA AND IDENTIFICATION OF PARTICIPANTS

Mexico requested that the Agenda be modified and that discussion on the Article 14 related to Cozumel be deleted at this time. Council Representatives agreed to informally discuss this item via teleconference on Friday 5 July at 8:30 AM. The Agenda was approved.

REMARKS BY THE CHAIR OF THE JPAC

In his remarks, Jonathan Plaut, Chair of JPAC, reported on the first regional public meeting held in Montreal. He also reported on preparations for the second regional public meeting to be held in San Diego as well as the public portion of the Council Session to be held in Toronto. A draft report of the first meeting will be available in early July. Council will be briefed of the outcome of these meetings over lunch on August 1 (refer to section on "Guidance to JPAC"). A final report will be produced by mid-September.

1996 REGULAR SESSION OF COUNCIL

Guidance to JPAC: Chair of JPAC presented the items which will be brought up by JPAC members during the course of a lunch with Council. These will include an update on the public meetings and a discussion on the 1997 Annual Program and Budget.

JPAC is responding to Council's request and inviting a Central American observer from The Comisión Centro Americana de Ambiente y Desarrollo (CCAD) and a Chilean observer from the Comisión Nacional del Medio Ambiente (CONAMA) to the JPAC session and Council Public Meeting.

Given the fact that the Secretariat received a request from the Head of UNEP North America to attend the Council Session as an observer, the Executive Director raised the question on the need for a policy concerning observers to the Council in-camera sessions. It was agreed at this time that the in-camera session should remain closed to all observers and that the question of a policy be reviewed at a future date.

Update on Public Meeting and Public Participation: 40 requests for presentations have been received so far. The Secretariat and Chair of JPAC will develop a proposal as to the selection of presenters taking into account the balance of nationalities, regions, industry sectors and topics, by July 12.

Progress Reports: The items subject to a progress report by the Secretariat were reviewed. Two additional items were added: Maps of North American Ecoregions and North American Integrated System for Environmental Management (including the border mapping initiative).

Canada and Mexico will submit their input regarding the 1997 Program to the Secretariat by July 5. Parties may circulate their comments to each other individually if they choose to do so.

The Executive Director pointed out Articles V, XII and XIII which are also pending. The Secretariat recognized the effort that has been made by Foreign Affairs Canada in resolving these issues. The Secretariat expects from Foreign Affairs Canada, the last version of the Headquarters Agreement in order to circulate to Parties and proceed with its signature

The Executive Director updated the Parties on this item and observed it was dependent on signature of the Headquarters Agreement

A new French version of the Agreement was sent by Canada to the Secretariat. It was suggested that this version could be approved by the Council in Toronto. The US pointed that it must first be reviewed by the Department of State, which might delay this process.

COUNCIL RESOLUTION: #96-1

1996 Program and Budget

THE COUNCIL:

APPROVES the 1996 Program and Budget submission dated March 7, 1996;

AUTHORIZES the Executive Director to implement the 1996 Program in conformity with the *North American Agreement on Environmental Cooperation*, the CEC rules and the relevant resolutions adopted by the Council;

AUTHORIZES AND DIRECTS, notwithstanding *Financial Rules* 5.3, 5.4 and 5.6, the immediate credit to the General Fund of the Commission, in accordance with *Financial Rule* 6.2(b), of that portion of the surplus funds for financial year 1995 equal to five percent (5%) of the Commission's budget for financial year 1995;

WAIVES, notwithstanding *Financial Rules* 5.3 and 5.4, the application of *Financial Rule* 5.6(b), to that portion of the surplus funds for financial year 1995 that would normally be credited thereunder in due course by the Commission against assessments of the United States and of Mexico and, at the request of such Parties, directs that such funds be applied to project 96-09-02 set forth in the 1996 Program and Budget submission dated March 7, 1996;

DIRECTS that the portion of the surplus funds for financial year 1995 which is to be credited against Canada's assessment in accordance with *Financial Rule* 5.6(b) be credited in financial year 1996;

REQUESTS the Executive Director to effect the definitive adjustment of the above application or crediting of surplus funds upon the close of the Commission's financial year 1996 as at December 31, 1996.
