Key Federal Laws Regarding Food Waste

Legal Protection

 Bill Emerson Good Samaritan Act of 1996 encourages individuals or businesses to donate food to nonprofits by minimizing liability.

Fiscal Policy

 Under U.S. Tax Code, corporations are able to deduct wholesome food donations from their tax liability (up to 15% of a donor's net income).

Solid Waste/Resource Conservation Authorities

- Under the Resource Conservation and Recovery Act (RCRA), Congress directed EPA to promote and advance resource conservation and recovery.
- RCRA delegates regulatory authority of non-hazardous waste, such as food waste to the states.





EPA's Approach to the Sustainable Management of Food

- > Set national goals, priorities, and measurement for reducing food loss and waste.
- Create voluntary, incentive-based programs to spur action.
- Develop tools and resources.
- Work with state, local, tribal governments to assist and support sustainable management of food practices and regulations.
- Build public-private partnerships and coalitions to promote action.








A Call to Action by Stakeholders: United States Food Loss & Waste 2030 Reduction Goal

The federal government, led by EPA and the United States Department of Agriculture (USDA), is seeking to work with communities, organizations and businesses along with our partners in state, tribal and local government to reduce food loss and waste by 50 percent over the next 15 years. As an important stride in reaching the 2030 food reduction goal, EPA hosted the Food Recovery Summitteet where organizations across the food chain, from manufacturers to consumers, met to discuss the key challenges in reducing food loss and waste. Based on this summit and continued input, EPA, USDA and stakeholders from across the food chain have developed a collaborative Call to Action, which identifies current opportunities and challenges in reducing food loss and waste in the United States.


