1. 1) Define the protocols for Transboundary Environmental Impact Assessments, as called for in the original NAAEC. 2) Standardize environmental regulations and secure one inspection of goods at the point of origin, to avoid costly reopening and inspection of containers at individual state, provincial, or even national borders. 3) Institute a uniform North American 'cap-and-trade' mechanism to reduce carbon emissions, and use the proceeds to create a sustainable infrastructure fund to invest in renewable energy sources, improved infrastructure, and mass transportation.

The CEC should act as a regular agency, homologating the environmental rules among the three countries. At the same time, a single environmental and commercial enforcement force needs to be created.
2. Training and homologation of the three countries' NGOs to act as transmitters of knowledge and awareness among the population in general and small-business exporters.
3. The most relevant in the European Community. A working group could be created with the EU. I have contacts with the European Delegation in Mexico and its programs. For example, the EU offered workshops to manufacturers and assembly plants through the Bancomext foreign trade bank, on waste management and European environmental standards.
4. Creating specialized, open environmental forums on key trade and environmental issues. Today, it is more important than ever to share experiences among the three countries and create specialized workshops depending on the industrial or commercial sector, to reach small and medium-sized businesses.
